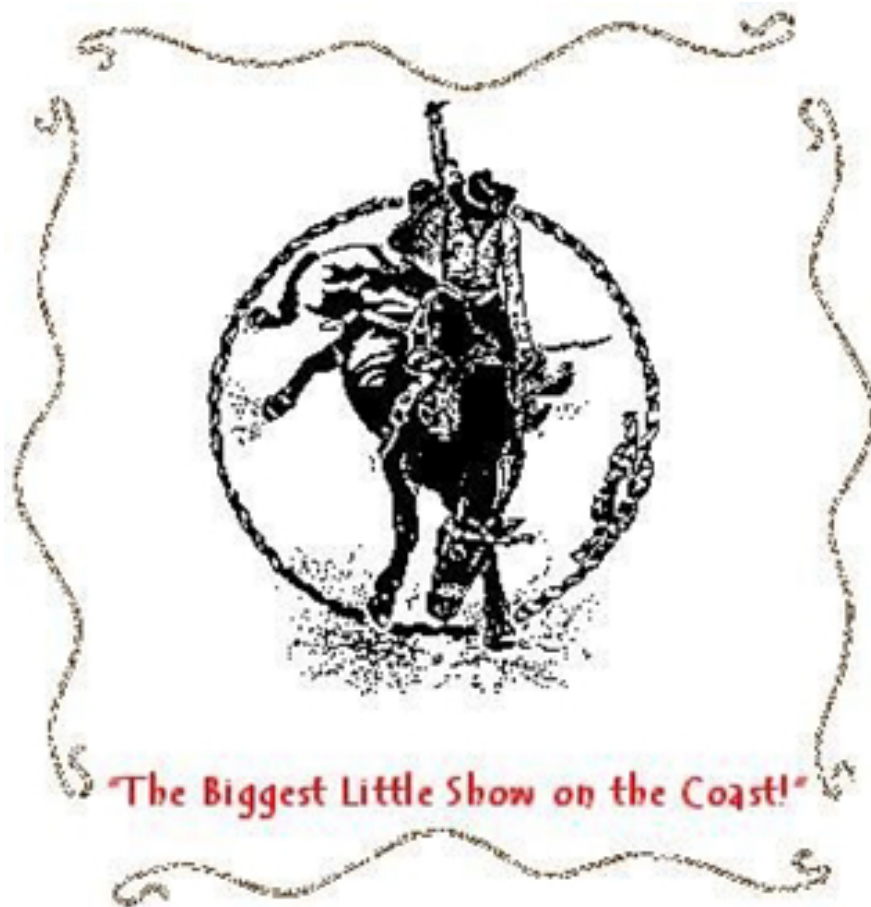


Tillamook County Rodeo

Tillamook County Rodeo Association is inviting all interested persons to tryout for the coveted title of Little Miss Tilly and Junior Miss Tillamook County Rodeo for 2024. Applicants must be **between the ages of 5 – 10**. Applicants must be a resident of Tillamook County. She should be outgoing and friendly. And eager to represent the TCRA with positive and family value attitude.

The Little Miss Tilly Pageant for the 2024 Little Miss Tilly will be held June 23rd & 24th, 2023 at the Tillamook County Fairgrounds and will include but not limited to: speaking, modeling, interviews, and participating in the Tillamook parade. ***Chaps are not allowed.*** Appearance must be clean and neat at all times. Clean and groomed hair, nails, hands face, etc.

The Little Miss Tilly Pageant is not judged. This event is to provide a fun relaxed atmosphere for the little girls and their parents without the pressure of winning or losing at such a young age. There will be no horsemanship competition or personal interviews for this age division, there will be, however, a few questions asked of each contestant at the Speech/Luncheon event. At the end of the pageant two Little Miss Tilly's will be crowned and each will receive a buckle, crown, and sash. All contestants will be required to participate in the Tillamook June Dairy parade on Saturday morning. Little Miss Tilly's will ride on a Tillamook County Rodeo float or Truck.

Contestants shall provide their own wardrobe. All contestants are required to wear clean well fitted clothes with no rips, tears or blemishes. A backup outfit should always be available. Below is a suggested wardrobe for the pageant.

- Queens Luncheon- Skirt or dress outfit, or pants outfit, any color the contestant chooses.
- Rodeo performances- Jeans, long sleeved shirt any color.
- Saturday Parade- **red, black, white may also use silver.** Outfit shall include western jeans, long sleeved shirt, may include a vest if desired.
- Saturday Coronation during the rodeo-western jeans, long sleeved shirt vest/jacket optional any color.
- **Western hat, western boots and belt are required with all outfits at all pageant events.**

Coronation for the newly selected Titleholders will be the first Saturday in November all chosen titleholders are required to attend. 2024 Titleholders will be only as busy as they want to be to during the spring and summer months traveling only with the approval of the Queen Coordinator. Events in 2024 they will be expected to attend are 2024 Tillamook County Rodeo/ Kid pony races specifically and Queen Pageant for 2025, 1 day of Tillamook County Fair, and the Court Coronation in November 2024. Other appearances that Little Miss Tillys are encouraged to attend are including, but not limited to parades, luncheons, radio interviews, coronation dinners. No monies are given to Little Miss Tillys by Tillamook Co. Rodeo Association, so title holders are encouraged to secure sponsors or have fund raisers (approved by queen coordinator) to fund their activities or out of pocket.
