
## Tillamook County Rodeo Little Miss Tillamook and Junior Miss TCRA Pageant Application for 2020

## Tillamook County Rodeo Little Miss Tillamook and Junior Miss TCRA Application for 2020

Tillamook County Rodeo Association is inviting all interested persons to tryout for the coveted title of Little Miss Tillamook and Junior Miss Tillamook County Rodeo for 2020. Applicants must be between the ages of 5 – 8 for Little Miss Tilly and 9-13 for Junior Miss TCRA. Applicants must be a resident of Tillamook County. The pageant for the 2020 Little Miss Tilly and Junior Miss TCRA will be held June 21<sup>st</sup> & 22<sup>nd</sup>, 2019 at the Tillamook County Fairgrounds and will include but not limited to:

<u>Little Miss Tillamook</u>: speaking, modeling, interviews, and participating in the Tillamook parade (If dates coordinate).

<u>Junior Miss TCRA</u>: speaking, modeling, interviews, and participating in the Tillamook parade (If dates coordinate).

All contestants are required to wear clean well fitted western shirt and jeans of any color, hat, belt and boots for all portions of the pageant. Contestant may wear a jacket or vest for the personal interviews. *Chaps are not allowed*. All contestants will be required to participate in the Tillamook June Dairy parade on Saturday morning. Little Miss Tillies will ride on TCRA float or Truck. Junior Miss TCRA will ride on float, truck, or their horses (approved by TCRA queen director). Titleholders can be very busy during the spring and summer months traveling to various speaking and rodeo events that she can select to attend only with the approval of the Queen Coordinator. Little Miss Tilly and Junior Miss TCRA is required to check in with TCRA queen coordinator before all TCRA rodeo board meetings and must be able to provide transportation and insurance for her horse (if horse is approved by TCRA) as well as herself. All contestants shall agree to adhere to all rules and regulations and shall sign all consents and waivers of liability. Applications must be postmarked by June 1st, 2019.

- Be available for all events and activities during reign that is approved by TCRA Board and (have a parent or guardian accompany you for Little Miss Tilly only.
- Wear western attire that is selected and approved by Queen Coordinator. Attire must be clean and free of tears or blemishes. A backup outfit should always be available.
- Appearance must be clean and neat at all times. Clean and groomed hair, nails, hands face, etc.
- To represent the TCRA with positive and family value attitude.

#### As Little Miss Tillamook (Tilly) you will be doing the following:

- 1. Participating in the Tillamook June Dairy Parade the year of your reign
- 2. Attend and work the Tillamook County Rodeo. Kid pony races especially
- 3. Attend the Tillamook County Rodeo Association Queen Coronation for the year of your reign and the following year.
- 4. Be available for appearances that are mutually decided between TCRA Queen Coordinator and parent/guardian/chaperone.
- 5. Distributing TCRA information as requested by the TCRA Board

#### As Junior Miss TCRA you will be doing the following:

- 1. Participating in the Tillamook June Dairy Parade the year of your reign
- 2. Attend and work the Tillamook County Rodeo. Kid pony races especially
- 3. Participating in TCRA grand entries. (in some form)
- 4. Attend the Tillamook County Rodeo Association Queen Coronation for the year of your reign and the following year.
- 5. Be available for appearances that are mutually decided between TCRA Queen Coordinator and parent/guardian/chaperone.

- 6. Distributing TCRA information as requested by TCRA Board
